COMMUNITY SERVICES DEPARTMENT 2016-2017 PROGRAM SUMMARY

Lake Community Action Agency is committed to providing quality services with impact and outcomes for families in our community. Our programs enhance and enrich lives by providing citizens with tools and resources that encourage self – sufficiency and improved standard of living.

Helping People... Changing Lives Community Action Helps:

- 7,582 unduplicated clients were served through the administration of the Community Services Block Grant, Weatherization, School Readiness and Voluntary Prekindergarten (VPK) and Low-Income Home Energy Assistance Programs.
- **2,895** households received assistance to maintain home energy through the administration of the **Low Income Home Energy Assistance Program** (LIHEAP).
- **44** Individuals obtained employment from October 1, 2016 through September 30, 2017.
- **18** households received assistance for Weatherization and Home Repair.
- 704 families received assistance through the Family Self Sufficiency Program.
- **15,696** meals were served to low-income children and youth through the administration of the Summer Foods Program at 21 sites throughout Lake County.











LCAA ENERGY SERVICES ACHIEVEMENTS

The Energy Services Department continues to provide stellar services in the delivery of our short-term and long-term energy programs for Lake Community Action Agency, Inc. In the department's mission we are poised to provide a unique range of energy solutions to Residential & Commercial customers through sound energy saving technologies, energy efficiency processes and conservation programs.

In our short-term energy solution program, titled as our LIHEAP Program, the department prevented the home energy crisis and restored home energy in over **1,255 homes** last year. Helping households avoid over **\$22,040** dollars in reconnect & late fees. The program is designed to assist eligible low-income households with their heating and cooling energy costs.

In our long-term energy solution program, Weatherization, the department weatherized over **17 homes** with over **42 individuals** benefitting from the Weatherization Program last year. The purpose of the Weatherization Assistance Program is to reduce the monthly energy burden on low-income households by improving the energy efficiency of the home and the health and safety of families. The Weatherization Program continues to be successful in creating jobs, and lower electric bills of struggling families in the communities we serve throughout Lake County.

The Energy Services Department experienced continued success in developing new revenue streams to expand existing programs through secured partnerships with our local municipalities in providing energy audits and construction management services to targeted areas of Mount Dora. The total investment of the projects combined totals over \$173,500 in energy efficiency upgrades and rehabilitation improvements. Additional partnerships are in progress with the Federal Home Loan Bank of Atlanta to provide Energy Efficiency Weatherization Rehabilitation & Accessibility Rehabilitation Products to median income families in Lake County.

The Energy Services Department will continue to secure vital programs and foster partnerships that will lead to significant investments in our local communities in Lake County. We are dedicated to creating more sustainable communities and creating jobs in the areas we serve.



FEATURE FSSP SUCCESS STORY DOMINIQUE BOSTIC

In January of 2016 Dominique Bostic came in to get assistance with education. Dominique was already going to school for Cosmetology but wanted to get into the Health Care profession. Dominique is a single mother and her only income at the moment is Temporary Assistance for Needy Families (TANF) is \$247.00 a month and she also receives food stamps. Because of her low-income she has to stay with others because she cannot afford a place of her own. Even though her present circumstances were not what she wanted, Dominique was determined to secure a better life.

As our conversation progressed, I informed her of the opportunity to attend the Lake Community Action Agency sponsored Achievement Training Model a Employability/Soft Skills Training Program. She agreed and attended the class. I then scheduled an appointment where I presented the Family Self-Sufficiency Program (FSSP) and she enrolled as a participant. With that we began to develop a personalized action plan and set goals with plans towards the future Dominique wanted to achieve.

As we began to move forward, there was one barrier that needed to be removed; Dominique had background issues that would prevent her from taking the State Nursing Board test that would license her to work in the Health Care field. Even though this obstacle occurred during her teenage years, our only option was to pursue obtaining an Exemption from Health Care Administration that would clear her so she could become employed in her desired career in the Health Care industry. This process took several months and while we waited, Dominique continued to attend other educational programs as a back-up plan.

In June of 2017, Dominique was approved by the State Board of Nursing Examination division to take the Certified Nursing Assistant exam. Dominique took the exam and passed with flying colors. DOMINIQUE NOW HAS HER CNA LICENSE and is working for an Assisted Living Facility that serves children and adults who have physical and mental disabilities, with an annual income of over \$30,000 A YEAR. She and her daughter are in their very own home and they are doing great!!



Dominique plans to continue her education because she wants to advance her career in the Health Care Profession.

Dominique's' success story was submitted to the South **Eastern Association of Community Action Agencies** (which represents the 8 states in the Southeastern region of the country) Conference for the **Lonnie D. Burton Achievement** Self-Sufficiency Award and she was the winner!!

The Achievement Training Model

In 2008 when our country experienced a drastic economic downturn, the federal government awarded grass root agencies funding to create and strengthen to workforce that would fill the employment vacancies once things got better. LCAA staff and other partners began to survey some of the local employers and asking this question: "what are some of your pressing issues as it relates to having a good employee?" The answer was one that was simple: "I need employees that have good people/soft skills because I can teach them the skills to perform the work I need but I do not have the time or resources to teach them how to be a good person." After researching, canvasing and laboring to address this response the Achievement Training Model Curriculum was birthed. The name Achievement Training Model suggests that each person has have deposits made into their lives that to them it is their normal way of carrying themselves. However, some of the cultural and diverse ways of behavior are not desirable in the work place. The ATM program gives participants a "for real" discussion on what employers value and influence them to view someone as "a good employee." The instruction is designed to help participants see that the information we teach, when applied, will increase their chances of securing and maintaining the career of their choice. The program stats for 2017 are as follows: 58 attended the training; of that 58, 20 took the C.N.A. course; 10 took the Phlebotomy course; 5 took the Home Health Aide course and 1 is enrolled into the LPN program. The status of the remaining 22 is as follows: some are addressing background issues and the others did not go any further with this program.

Achievement Training Model Feature Success Story: Ms. Nellie Hatcher

Eustis resident Nellie Hatcher came to our Employability/Soft Skills, Achievement Training Model (ATM) class. Utilizing this program and putting into practice the 15 standards we share with our clients provided her with the necessary tools to advance her towards achieving self-

sufficiency. Nellie was childcare facility not earning needed to be self-sufficient. and wanted something attending the ATM training Technical Institute with through our Community stream and became a started out working in the Leesburg, where she got



working part time at a the kind of income she She has two small children better for them. After she attended Southern financial assistance Service Block Grant funding Phlebotomist. Nellie North Campus Hospital in most of her training and

experience in Phlebotomy. She soon applied and got a position working for Quest Diagnostics, a leading Laboratory in Lake County. Nellie has been with Quest for almost a year making more than sufficient income and does not need or qualify for government assistance of any kind. Congratulations to Nellie Hatcher for striving to do better for herself and her family.

Lake Community Action Agency, Inc. Montclair VPK/School Readiness Program

The following is a summary of the educational services provided and progress that was demonstrated by the high-risk underserved low-income pre-school children ages 1 to 5 as a result of the Childcare services provided by Lake Community Action Agency, Inc. This program provided educational assistance to develop the following areas of Learning and Child Development:

- Print Knowledge
- Phonological Awareness
- ♣ Oral Language/Vocabulary
- Mathematics

The results of the initial assessment was performed in October 2016, show that in the area of Print Knowledge:

- ❖ 71% of the students tested were below expectations
- ❖ 21% were meeting expectations
- ❖ 7% was exceeding expectations

In the area of Phonological Awareness:

- ❖ 79% of the students were below expectations
- ❖ No students were meeting expectations
- No students were exceeding expectations

In the areas of Oral Language and Vocabulary:

- ❖ 79% of the students tested were below expectations
- ❖ No students were meeting expectations
- ❖ 21% of the students were exceeding expectations

In the area of Mathematics:

- ❖ 71% of the students were below expectations
- ❖ 14% of the students were meeting expectations
- ❖ 14% of the students were exceeding expectations

The nest assessment was performed in March of 2017 and the results are as follows:

Print Knowledge:

- ➤ 67% are below expectations which is a 4% decrease in this area
- ➤ 22% are meeting expectations which is a 1% increase in this area
- ➤ 11% are exceeding expectations which is and 4% increase in this area

In the area of Phonological Awareness:

- ➤ 28% of the students are below expectations, a decrease of 51% in this area
- ➤ 17% are now meeting expectations
- > 56% are now exceeding expectations in this area

In the area of Oral Language and Vocabulary:

- ➤ 39% are now below expectations, a decrease of 40% in this area
- ➤ 17% are now meeting expectations and increase of 17%
- ➤ 44% are exceeding expectations, an increase of 23%

In the area of Mathematics:

- ➤ 44% of the students are below expectations, a decrease of 27%
- ➤ 28% are meeting expectations, this is up 14%
- ➤ 25% are exceeding expectations, an increase from the original 14%



The impact of the program this year is that, Lake Community Action Agency was able to offer Childcare services to 47 high-risk underserved low-income pre-school age children ages 1 to 5 and provide the families of those children with wrap around services coupled with intense case management to help them obtain a greater level of self-sufficiency. The objective of this program is to assist at-risk households with services that can aide them in becoming economically self-sufficient by removing barriers that prevent self-sufficiency in achieving family stability (i.e. Early Childhood educational services, employment, housing).



Mrs. Linda Watts and The Miss Leesburg Scholarship Program and the Shang Ra La Senior Mobile Home Community adopted our Childcare Center and shared Christmas gifts with the children December 2017.


